**\*PLEASE NOTE THAT ALL CURRENT TOLL TAGS WILL BE RENEWED YOU WILL NOT BE ISSUED NEW TOLL TAG STICKERS. DO NOT REMOVE YOUR TOLL TAG STICKERS. NEW TOLL TAG STICKERS WILL ONLY BE ISSUED FOR VEHICLES THAT HAVE NOT BEEN PREVIOUSLY REGISTERED.**

(Member, Spouse and Children, 25 or Under Living in the Home)

**Immediate Family Toll Tag Renewal: \$50.00 New Toll Tag \$50.00**

(Children Not Living in the Home, Parents/In-Laws, Siblings/In-Laws, Grandparents, Grandchildren)

**\*Replacement Toll Tags \$10.00 accompanied with previously issued Toll Tag\***

**Golf Cart, Cycle, UTV, ATV \$30.00**

**Motorized Watercraft 1<sup>st</sup>-\$35.00, 2<sup>nd</sup> \$70.00 (Limit 2)**

**Jet Ski 1<sup>st</sup> \$60.00, 2<sup>nd</sup> \$120.00 (Limit 2)**

**PROOF OF OWNERSHIP (TITLE, REGISTRATION, OR BILL OF SALE) AND INSURANCE ARE REQUIRED WHICH MUST BE IN EITHER THE MEMBERS NAME, MEMBER'S SPOUSES NAME, OR DOMESTIC PARTNERS NAME ONLY. IF DUALY TITLED IT WILL ONLY BE ACCEPTED IF BOTH NAMED ARE MEMBERS.**

**Non-Motorized Watercraft \$10.00 (Canoes, Water Wagons, Kayak's, Paddle Boat, etc)**

**Domestic \$5.00 per name/business**

**Yearly Standing Guest List \$5.00 per name (up to 5 guests)**

**If not placed on file as of February 1, 2019 they will be denied access.**

**All Stickers issued are on a first come first serve basis. Stickers will be available for purchase January 2, 2019 thru January 31, 2019 until 4 p.m. all sticker prices will Double after January 31, 2019 after 4 p.m.**
